Applications are invited from the citizens of India as defined in Article 5 and 6 of the Constitution of India for filling up of the post of 1 (one) Developer (Contractual) basis at a fixed pay of **Rs. 25,209/-** subject to availability of the project and allocation of funds by the e-Committee, Supreme Court of India. The selected candidate will be posted in the Gauhati High Court, Aizawl Bench, Aizawl and under no circumstances can claim regularization of his service.

Candidate must not be less than 18 years and more than 38 years of age as on the last date of submitting application. The upper age limit will be relaxable by 5 years for Person with Disabilities and candidates belonging to SC and ST category.

**Eligibility**

BE/ B.Tech/M.Sc/ MCA with specialization in Computer Science/ Electronics/ IT with knowledge of software development in PHP+PostgreSQL / MySQL environment.

**Selection Process**

Selection process will be notified in due course.

**How to Apply**

Candidates who fulfill the requisite criteria can submit their application to the undersigned on or before **18.06.2019** during office hours.

Indian Postal Order (IPO) of Rs. 340/- (Rupees Three hundred forty) only for General candidates and Rs. 170/- (Rupees One hundred seventy) only in case of Scheduled Caste/Scheduled Tribe candidates payable to Registrar, Gauhati High Court, Aizawl Bench, Aizawl, Mizoram.

**Terms and Conditions:**

- i. Any information submitted by an applicant in his application will bind the candidate personally and if found to be false shall be liable to for criminal prosecution apart from consequences in civil law as may be deemed necessary by the High Court.

- ii. The Gauhati High Court reserves the right to cancel the advertisement, modify or alter any terms and conditions of the advertisement at any stage.
- iii. Merely satisfying the eligibility criteria do not entitle a candidate to be called for the written examination/skill test/interview etc.
- iv. No person, who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post.
- v. The admission of candidates at all stages of the selection process will be purely provisional and subject to their satisfying the prescribed eligibility criteria. If, on verification at any time before or after the selection process, it is found that a candidate does not fulfil any of the eligibility conditions, his/her candidature shall stand cancelled without any notice. Mere calling of candidate to written test/ skill test/ interview etc. or issuance of admit card/ call letter etc. does not necessarily mean acceptance of candidature of any candidate which shall be further scrutinized at every stage and the High Court reserves the right to reject the candidature of any candidate at any time.
