Dated Guwahati, the 4th July, 2020

Hon'ble the Chief Justice has been pleased to issue the following guidelines, till further orders:-

1. From various national and local news channels, it has now become known that possibly Covid-19 is transmitting through community in the North Eastern States. The number of Covid-19 positive cases is mushrooming day by day in all strata of society.

It has been reported that even the Court complexes have not been spared. Covid-19 infected persons have been traced from amongst the advocate's fraternity, as also the Judges serving in the District Courts. It appears that the safeguards required to be applied are not being adopted. Face masks are not being worn and social distancing is not being maintained, resulting in such spread.

2. In the changed scenario, it has become administratively imperative to curtail the Court functioning at all levels i.e. in the subordinate Courts, as also at the High Court level, in the Principal Seat of Gauhati High Court at Guwahati, and in the outlying benches at Nagaland, Mizoram And Arunachal Pradesh.

3. In view of the above, it is hereby directed that only cases of emergent nature involving personal liberty viz. bail matters, remand matters, habeas corpus petitions; recording of statement under Section 164 Cr.P.C.; and matters involving utmost urgency in which there is a genuine need for stay of some action, would be listed for hearing, till further orders.

In such cases, request for listing and hearing may be made by the counsel concerned which would be considered, considering the nature of the matter.

4. Filing of all cases, however, would be permitted.


