1. Maximum age limit for applying to the said 2 (two) categories of posts will be 37 (thirty seven) years. Relaxation of age will be applicable as per the existing rules prevailing in the State of Mizoram notified from time to time.
2. Minimum educational qualification for applying to the post Chauffeur will be **"Passed in Class VIII or above from a recognized Institution and must possess valid LMV driving license issued by competent authority"**

Accordingly, fresh applications are invited from the citizens of India as defined under Article 5 and 6 of the Constitution of India for filling up the said vacant posts already notified.
