Candidates of the provisional list have been allowed to appear in the Preliminary Examination subject to the condition that their candidature will continue to be under scrutiny. The Gauhati High Court reserves the right to reject the candidature of any candidate on detection of any ineligibility condition at any stage.

Further, the Gauhati High Court has been pleased to publish an additional provisional list allowing 1 (one) additional candidate to appear in the preliminary examination. The additional provisional list has been published along with this notification.
