- (iv) The court fee levied on criminal appeals shall also be levied on appeal under section 42 of PMLA.



(i) Such cases shall be categorized under a new category code –

10310 – Citizenship, NRC, pushback / deportation and other ancillary matters.

(ii) This category of cases shall be listed before the Division Bench taking up Foreigners Tribunal matters. However, matters pertaining to D-Voters and connected matters shall continue to be listed as per Hon'ble Gauhati High Court's earlier Order No. 11 dated 22.01.2019, i.e., before Single Bench.
