The Registry (*Filing Section / Stamp Reporters*) is directed to ensure strict compliance with this Order at the time of scrutiny and registration of cases.

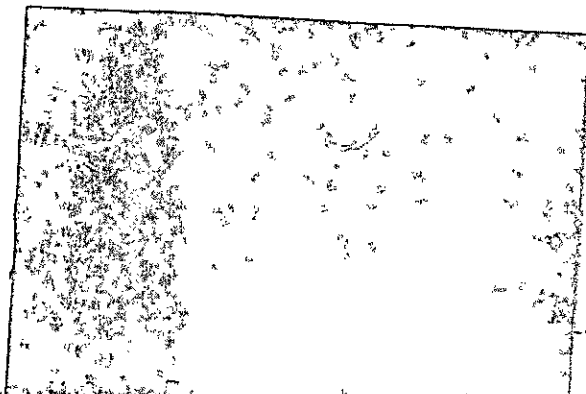
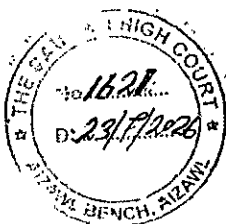
