The learned advocates who have sufficient infrastructure to conduct cases from their own residences/chambers may participate in the Court proceedings subject to fulfillment of requirements such as having the applicable video conferencing software (Google Meet) and an internet connection with bandwidth not less than 5 mbps.

The learned advocates who choose to appear before the Hon'ble Courts at Aizawl Bench via remote VC shall be required to give intimation to the Computer Cell of this Registry at least 1(one) working day before the proposed hearing on any of the following numbers:
