NOTIFICATION

Dated Aizawl, the 17th August, 2020

Pursuant to the Order dated 16.08.2020 issued by the Government of Mizoram, wherein, Total Lockdown has been imposed within the Aizawl Municipal Area w.e.f 16.08.2020 @ 8:00 PM to 21.08.2020 @4:00 AM and with the approval of Hon'ble the Chief Justice, Gauhati High Court, it is hereby notified that the instructions and guidelines issued by the Gauhati High Court, Guwahati vide Notification No. 53 dated 31.07.2020 in respect of the functioning of Courts in Gauhati High Court at Guwahati, 2 (two) Outlying Benches of Kohima and Itanagar and the Subordinate Courts of the aforesaid States, are extended to the Aizawl Bench of Gauhati High Court and all the Courts/Tribunals within Aizawl District with immediate effect and until further Orders.

Functioning of Courts as per Notification No. 53 dated 31.07.2020 is restricted to cases of emergent nature involving personal liberty, viz. bail matters, remand matters, habeas corpus petitions, recording of statement under Section 164 Cr.P.C, Zimma petitions and other matters involving utmost urgency in which there is genuine need for stay would be considered for hearing. However, filing of case is permitted in all Courts under the administrative control of Gauhati High Court.

Cases considered for hearing in terms of the Notification No. 53 dated 31.07.2020 can be conducted through video conferencing, as per convenience.
