NOTIFICATION

In cancellation of this Registry's notification of even no. 137-138 dated 20.04.2021, corrigendum even no. 146 dated 28.04.2021 and notification of even no. 151 dated 05.04.2021, it is hereby notified that;

Whereas Hon'ble the Chief Justice of the Gauhati High Court has been pleased to issue directions vide Notification No.28 Dated 19th April, 2021 regulating the workings of the Gauhati High Court in its Principal Seat at Guwahati, as well as its Outlying Benches at Kohima, Aizawl and Itanagar and all subordinate Courts in the states of Assam, Nagaland, Mizoram and Arunachal Pradesh in the wake of the recent surge in cases of Covid-19;

Now, in terms of the aforesaid Notification at para (vi) the following directions are hereby issued:

- 1) For urgent listing of matters in the Aizawl Bench of the Gauhati High Court, learned Advocates shall request with cogent reasons for such listing of the matters via email to the Hon'ble Courts at Aizawl Bench in the email ID urgentcase.aizawlbench@gmail.com in the prescribed 'Mention Form for Urgent Listing of Cases' notified by the Principal Seat in its Notice dated. 28.09.20 and enclosed in this Notification.
- 2) The Memos shall be required to be sent through the email ID aforesaid by 11:00 am and the learned advocates must retain the originals of the memo as prescribed in Principal Seat Notice Dated. 28.09.20.
- 3) The Memos once received shall be placed before the concerned Hon'ble Judge holding a particular roster on a given date. Once the Hon'ble Judge

is of the view that the matter is of urgent nature, the same shall be listed before the Court.

As per the direction in Notification No. 28 Dated 19th April, 2021 all learned advocates attending matters at the Gauhati High Court Aizawl Bench shall maintain all Standard Operating Procedures pertaining to Social Distancing and wearing of masks and no person, except the learned Advocates and/or parties appearing in person to address the Hon'ble Courts, shall be permitted in the Court rooms.

Further, in view of the Notification No. 29 Dt. 20th April, 2021 of the Gauhati High Court and other Notifications issued thereafter requiring all Courts in the Principal Seat and the Outlying Benches of the Hon'ble Gauhati High Court to function in virtual mode with staggered roster;

And in view of the regulation of Court functioning as aforesaid and in terms of Notification Dt. 15th April, 2020 of the Gauhati High Court, it is made clear that learned advocates who prefer to come to the Courts to argue their cases, if they have no sufficient infrastructure of their own, may do so.

The learned advocates who have sufficient infrastructure to conduct cases from their own residence/chambers may participate in the Court proceedings subject to fulfillment of requirements such as having the applicable video conferencing software (Google Meet) and an internet connection with bandwidth not less than 5 mbps.

The learned advocates shall be required to give intimation to the Computer Cell of this Registry at least 1(one) working day before the proposed hearing on any of the following numbers:

The Computer Cell upon receipt of such intimation will give necessary intimation to the Judicial Section of this Registry.

A link to participate in the court proceeding shall be sent to the concerned advocate by the Registry immediately before the time of hearing of the case and the concerned advocate shall join the video conferencing facility using Google Meet application.

Any time slot if allotted against a case shall be adhered to by the learned advocates.
