

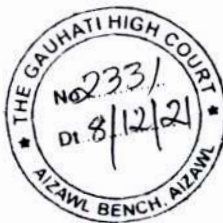
The following directives may be followed for submission of the scanned copies of judgments:


