
No individual call letter will be issued to any candidate in any other mode.

The aforementioned candidate is directed to bring all the relevant testimonials relating to age proof (Class X admit card/birth certificate), educational qualifications (marksheets and pass certificates), experience certificate, category certificate (if applicable), in original along with a set of self-attested photocopies. The candidate is also directed to submit a copy of the admit card of the written examination/skill test and two recent passport size color photographs. The self-attested photocopies of the documents shall have to be handed over at the time of the Interview/Viva-voce. If the candidate is already employed in the Central/State Govt. Service or Undertakings, he/she shall have to produce *No Objection Certificate* (NOC) from the present employer.

Calling of the candidate to the Interview/Viva-Voce is purely provisional and does not mean acceptance of his/her candidature, which shall be further scrutinized and the High Court reserves the right to reject the candidature of any candidate on detection of any ineligibility at any stage. The candidature of the candidate shall be subject to fulfillment of all the


